### TO WHOM SO EVER IT MAY CONCERN

This is to inform you that as per the Uttar Pradesh Private University's Act 2019 dated 06/08/2019, Swami Vivekanand Subharti University is now governed by the same. Due to its location in Meerut, Uttar Pradesh (image 1), the ACT gives the power to the University to form its own Statutes by virtue of Article 3 (j) which is quoted herein below:





Image 1: Umbrella Act 2019

**"3. Conditions for the establishment of the University. - The sponsoring body shall, for the purposes of establishing the University under this Act, fulfill the following conditions, namely-**

**(j) make the Statutes, Ordinances and Regulations for the administration and functioning of the University;"**



- (j) make the Statutes, Ordinances, and Regulations for the administration and functioning of the University;
- (k) any arrangements made by the University shall not be inconsistent to the provisions of this Act and regulations of the regulatory bodies;
- (l) to ensure transparent functioning of the University and shall put the clearances obtained from the Regulatory Bodies in the public domain;
- (m) furnish information to the State Government as per format and periodically required by the State Government;
- (n) comply with the norms set up by the State Government for common academic calendar, and copying measures, admissions, examinations, degrees and certificates etc.;
- (o) the transparent procedure and standard of admissions and fee structure in the University shall be decided and placed in the public domain before the start of the admission process. The last date of admission shall be as per the common academic calendar;
- Admission policy of foreign students shall be decided by the Executive Council of the University and shall be consistent with the standards laid down by the State Government and Regulatory Bodies;
- (p) follow the Common academic calendar as may be prescribed; and
- (q) to undertake to fulfill such other conditions consistent with this Act as may be laid down by the State Government before the establishment of the University;

### Image 2: Formation of Statutes

The Act gives the power to the University to establish Departments for the purpose of spreading education by virtue of Article 11 (n) which is quoted herein below:

**"11. Powers of the University. - Subject to the guidelines and norms as prescribed by the Regulatory Bodies and the State Government from time to time the University shall have the powers,-**

**(n) to establish a faculty, a department, a centre, or school, as the case may be, in accordance with the Act and Statutes;"**

<p style="text-align: center;"><b>Statutes of University</b></p> <p>Subject to the guidelines and norms as prescribed by the Regulatory Bodies and the State Government from time to time the University shall have the powers,-</p> <ul style="list-style-type: none"> <li>(a) to provide for instruction in such branches of learning as the University may, from time to time, determine and to make provisions for research and for the advancement and dissemination of knowledge and skills;</li> <li>(b) to provide for instruction in such branches of learning as the University may think fit and to make provisions for research and for the advancement and dissemination of knowledge;</li> <li>(c) to honour educational institutions and persons of academic eminence with designation of professor Emeritus;</li> <li>(d) to grant, subject to such conditions as the University may determine, diplomas or certificates to, and confer degrees, or other academic distinctions on the basis of examinations, undertaken or any other method of testing of persons, and to withdraw any such diplomas, certificates, degrees or other academic distinctions for good and sufficient cause;</li> </ul>

- (c) to confer honorary degrees or other distinctions with prior approval of the State Government;
- (d) to bestow as per norms of Regulatory Authorities and State Government Directorships, Professorships, Associate Professorships, Assistant Professorships, and other teaching or academic posts required by the University and to make appointments for the same;
- (e) to create administrative, ministerial and other posts and to make appointments thereto;
- (f) to appoint/engage persons of eminence, working in any other University or organization permanently or for a specified period;
- (g) to co-operate, collaborate or associate with any other University or Authority or Institution in India and abroad in such manner and for such purpose as the University may determine;
- (h) to establish and maintain schools, centres, specialized laboratories in other units for research and instruction as are in the opinion of the University, necessary for the furtherance of its objects;
- (i) to institute and award fellowships, scholarships, studentships, medals and prizes;
- (j) to establish, maintain and supervise residences, hostels and promote the health and general welfare activities for students and staff;
- (m) to make provisions for research and consultancy, and for that purpose to enter into such arrangements with other institutions or bodies as the University may deem necessary;
- (n) to establish a faculty, a department, a centre, or school, as the case may be, in accordance with the Act and Statutes;
- (o) to determine standards in accordance with the State Government and other Regulatory Bodies for admissions into the University, which may include examination, evaluation or any other method of testing to ensure quality;
- (p) to demand and receive payment of fees and other charges;
- (q) to make special arrangements in respect of women and other disadvantaged students as the University may consider desirable;
- (r) to regulate and enforce discipline among the employees and students of the University and take such disciplinary measures in this regards as may be deemed necessary by the University;
- (s) to make arrangements for promoting the health and general welfare of the employees of the University;
- (t) to receive donations and to acquire, hold and manage any property, movable or immovable for the welfare of the University;
- (u) to ensure that no immovable property shall be disposed off or rights or title therein parted with or any liability created thereon, by any of the officers or authorities of the University, except after prior approval of the State Government;
- (v) to appoint either on contract or otherwise, visiting professors, consultants, fellows, scholars, artists, course directors and such other persons who may contribute to the advancement of the objects of the University;
- (w) to organize and to undertake educational studies and extension service; and
- (x) to do all such other acts and things as may be necessary, incidental or conducive to the attainment of all or any of the objects of the University.

**"23. Correspondence Course/ Distance Education/On Line Courses:**

*Consistent with the provisions of Article 15(3) of the Constitution of India, it shall be open to the University to make special arrangement in respect of women students, as it may consider desirable.*
